# All Aboard for Our 56<sup>th</sup> Annual Meeting... La Fonda on the Plaza, Santa Fe, New Mexico, February 15–18, 2017

Santa Fe, New Mexico, possesses all the attributes of the ideal WRSA meeting venue: a smallish city with a unique culture and vibe; great food and drink options; a lovely historic hotel; and all in an eminently walkable location. For its 56<sup>th</sup> annual meeting, the WRSA returns to Santa Fe and to the La Fonda on the Plaza hotel. Many will remember both, as the WRSA met here in 2006 and also hosted the 1998 North American Meetings of the RSAI at this hotel. If we're going back a third time, you know it must be good.

For those hoping to get started early with travel planning, our 2017 meeting will open on a Wednesday (the 15<sup>th</sup>), with the Lay James Gibson plenary and Welcoming Reception. Three full days of paper sessions and social activities follow, on Thursday, Friday, and Saturday.

The La Fonda is already accepting reservations for our room block. Our negotiated room rate is

\$149/night, plus taxes, and includes internet and parking. The hotel has agreed to honor our room rate three days prior to and following our official meeting dates, for those who would like to extend their visit to Santa Fe a bit. Reservation instructions can be found on our website (www.wrsa.info). After January 13, 2017, or as soon as our room block fills, the hotel is no longer obliged to honor this excellent room rate. Book early!

And although our traditional paper submission deadline isn't until **October 15**, our online submission portal is also already up and running. As soon as you have those draft papers completed, we're ready to accept them! Remember, as always, only full papers will be considered for inclusion on the program and all submissions are reviewed by a member of the Program Committee before invitations are issued. Papers in draft format at the time of submission are acceptable, however.

## Our 55<sup>th</sup> Annual Meeting: Hawaiian Highlights

Our Hawaii meetings are typically among our most popular, and for good reason. The remote, tropical locale lends itself well to the sharing of intellectual ideas and the building of disciplinary camaraderie. The fact that all this takes place in February, a cold and dreary time of the year for many of our participants, doesn't hurt either.

This year's annual meeting, on the Big Island of Hawaii, was no exception. It attracted over 200 participants from about 20 different countries. The program featured 41 paper or panel sessions, including the long-running Remote Regions sessions and the Western States Economic Outlook session.

Plenary speakers are always a high point of the meeting. This year Peter Fuleky and Makena Coffman from the University of Hawaii got the meeting off to a strong start at the 6<sup>th</sup> Annual Lay James Gibson Plenary Opening Session. Attendance was strong, too, at Monday's Getis-Ord Lecture in Spatial Analysis. This year's lecture, the fourth, was given by noted urban economist Edward Glaeser, from Harvard University. Glaeser spoke on the subject of urbanization and economic development.

The apex of the annual meeting is the Annual Banquet Luncheon, during which prizes are awarded (see separate stories in this *Newsletter*) and the WRSA President gives his or her address. This year's President, David Plane from the University of Arizona, spoke on the subject of "Regional Science in a More/Less World," with discussant remarks given by his longtime colleague, Gordon Mulligan.

## Xian Fang Bak Wins Tiebout Prize

This year's Tiebout Prize, the 30<sup>th</sup>, was awarded to Xian Fang Bak from the University of Illinois, Urbana-Champagne, for her paper titled, "Measuring Foreclosure Impact Mitigation: Evidence from the Neighborhood Stabilization Program in Chicago." Bak's research was supervised by Geoff Hewings.

The Tiebout Prize Reading Committee also selected one finalist this year, Esteban Lopez Ochoa, for his paper, "Urban Renewal, Residential Mobility and Location Choice as the Product of Housing Displacement: An Ex-ante Analysis." Lopez Ochoa's advisor is Geoff Hewings, as well. Congratulations to both winners!

The Tiebout Prize is given in memory of Charles Tiebout and his contributions to regional science, in particular his mentoring of graduate students. Winners of the Prize receive \$1,000 to help defray the costs associated with attending the annual meeting. Every year, the Tiebout Prize Reading Committee, comprised of past WRSA Presidents, evaluates a large pool of submissions. ## Springer Prize Goes to Karl Geisler

Every year Springer, publishers of the WRSA's official journal, *The Annals of Regional Science*, offers a prize for the best paper given at the meeting by a junior scholar (doctoral degree received within the past five years). The Springer Prize comes with a \$500 book voucher and a certificate. This year's 20<sup>th</sup> Prize was awarded to Karl Geisler, from the University of New Mexico, for his paper, "Tourism, Las Vegas, and The Hangover: Quantifying a Major Motion Picture's Impacts on Visitor Volume."



## Changes to Tiebout and Springer Prize Submission Processes

At its annual business meeting, the WRSA Board agreed to update the submission processes for both the Tiebout and Springer Prizes. Effective immediately, submissions for both prizes will be integrated into the existing online paper submission portal.

The Tiebout Prize is awarded for the best paper submitted by a current (or recently finished) doctoral student in the field of regional science. Further information about the Tiebout Prize is available on the WRSA website. Those wishing to have their papers considered for the 31<sup>st</sup> annual Tiebout Prize should upload their papers to the WRSA system and be sure to check the appropriate box for the Tiebout Prize (see graphic below). The required cover sheet information should be included as part of the manuscript pdf. Paper copies should no longer be mailed to the WRSA office!

The Springer Prize is awarded to early career scholars (those who completed their degrees within the past five years) presenting a paper at the WRSA conference. To be considered for this award, simply check the "Springer Prize" option during the usual submission process (see below).
